1. HWLB @ 1412hrs BST predicted @ 7.1m. HW Brentford @ 1512hrs +/-.
2. Thames Lock Brentford staffed between 1315 – 1715, if booked in advance.
3. Depart SPCC by own arrangement. Rendezvous in Limehouse Basin NLT 0930hrs.
4. Short safety brief followed by departure from 1000hrs, depending on number of boats registered.
5. Limehouse and Brentford Lock capacity will be booked by the cruise co-coordinator.

1. Please let me know if you plan to return to Limehouse via the Tideway on Sun 01 or Mon 02 Apr.
2. Return timings TBC. Thames Lock Brentford staffed from 1430 Sun & 1515 Mon.
